



## Loving v. Virginia (1967): Lesson Plan

Topic	
<p>In a unanimous decision, the Court found anti-miscegenation laws as violations of both the Equal Protection Clause and the Due Process Clause of the Fourteenth Amendment. The Court also struck down all laws banning interracial marriage in the sixteen states still using them. The case went on to be cited in <i>Obergefell v. Hodges</i> (2015), which legalized same-sex marriage.</p>

1. Why do you think segregationists and white supremacists supported laws banning interracial marriage?
2. Are you surprised at how relatively recent the *Loving* case is? Why do you think interracial marriage is commonplace today but was illegal in many states barely fifty years ago?
3. What do you think about the decision in *Pace v. Alabama*, which upheld anti-miscegenation laws because they impacted both races equally? Was that true? Does the intent behind laws matter?

### Activity Ideas

- Write about the interracial, interfaith, or interethnic relationships within your own friends and family. Talk about the importance of combining and learning from different cultures and backgrounds. You may also talk about the unique challenges of these relationships. Write a short essay on the topic, around two to four paragraphs.
- Watch this [trailer](#) for the movie based on the Lovings, titled *Loving*. Read an [article](#) about what Loving's grandson Mark Loving II has to say about the film and his famous grandparents. Hold small group discussions on the film and its representation of the Loving family.
